

## ENVIRONMENTAL POLICY.

### AB Skånesten

We will be a company that works for a better environment by constantly evaluating what we do based on its environmental impact.

We will therefore:

- Increase knowledge and raise awareness of environmental issues among all employees.
- Influence, set demands on and cooperate with other companies, suppliers, authorities and organizations.
- See environmental improvement measures as investments.
- Prevent pollution in air, soil and water by considering the environmental impact of what we do.
- Constantly strive to improve the utilization of our resources within the company.

### Environmental organization

From 2017 onwards, environmental issues will be managed by a special environmental manager, **Jonas Svensson**. The environmental manager will increase coordination and integration in the business and with our suppliers. Our environmental work, which began in 2016, includes projects and activities related to all operations in the company.

In order to achieve harmonization and standardization of our quality work in the long term, integration is underway in connection with our business development.

Through continuous staff meetings and discussions with customers and suppliers, we can help each other move environmental work forward throughout the company.

## **Plan of Action**

We have established a plan of action based on our objectives.

The plan of action is as follows:

- **Cleaning and source separation**

*We clean and source separate our waste in our workplaces. We shall handle hazardous waste in an environmentally safe manner. This can be, for example; batteries, chemicals, waste oil, joint and sealant, electronic equipment, etc.*

- **Energy saving measures**

*A set goal is to increase the use of computers and adequate software to reduce the use of paper to disseminate information to staff, customers and suppliers, examples of this can be daily reports sent via text message or invoices sent via email. The company uses manual tools such as chisels to cut natural stone to a large extent.*

- **Environmentally friendly purchasing**

*A set goal is to always consider environmental aspects when purchasing products used in the business, everything from vehicles and fuels to copy paper and pens. This has led to a transition to more environmentally friendly products.*

- **Environmental requirements for our products and services**

*The services we market should be environmentally friendly to the greatest extent possible. An example of this is that when we clean natural stone from discoloration, we use an environmentally friendly agent. Furthermore, we use manual/mechanical tools such as wheelbarrows and curb cutters instead of motor-driven machines to the greatest extent possible when performing work.*

- **Environmental requirements for our suppliers**


*We work to the greatest extent possible with companies that have continuous environmental work within the organization and a clear and distinct environmental policy.*

- **Use of the best possible fuel and Reduced fuel consumption**

*One of the environmental goals set for the business prescribes the best possible fuel and requirements for measures to reduce fuel consumption. Examples of this could be carpooling to and from the workplace and never letting machines, such as chainsaws, idle.*

**• Environmental information for employees, customers and suppliers**

*All employees in the business should be aware of the company's environmental goals. This is followed up regularly, for example at staff meetings or at breakfast/lunch at the workplace. A continuous discussion at the workplace during working hours is carried out on an ongoing basis.*
